RIA typically allows up to four days to obtain an authorization. Due to the volume of request, we do ask that referring physician's office obtain authorizations for same day (STAT) appointments.

RIA accepts most insurances however not all insurance companies allow imaging providers to obtain the authorization on your behalf (e.g., United Healthcare, Humana, VA Medicaid and some Anthem BCBS/OUT of State BCBS).
